# **Services at Clinic Premises**

### **Occupational Medicine:**

- Occupational health consultations: Including pre-employment medicals, periodical medicals, deployment medicals, return to work medicals, occupational health related screenings, investigation of the causes of occupational impairment of health.
- **Preventive medical services**: A large proportion of diseases and disorders, such as diabetes, hypertension, heart disease and colon cancer are preventable. Many modifiable health risks such as lack of exercise, poor nutrition, obesity, stress and smoking are associated with increased healthcare cost.
- Wellness programs: Either individual or corporate wellness programs and plans are developed for each patient/ corporate client, considering all requirements and based on gender, age and job type. Under this category, evaluation starts from executive medicals, general medical screenings, as part of preventive medical services and can be extended to specifically designed corporate wellness programs, including not only the physical health aspect, but also the mental health, environmental and family requirements.
- General medical services: Including the diagnostic and treatments of acute diseases, management of chronic diseases, general screenings and treatments etc.
- **Travel medicine and adult vaccination programs**: For employees and their families, traveling either for business or for personal purposes or for those who wants to keep their routine vaccination up to date, as per World Health Organization (WHO) and CDC recommendations.
- Mental health support: for employees and corporate programs for management of stress in the workplace.

### **General Medicine:**

- General medical consultations for acute and chronic medical conditions: diagnostic, management and treatment of common acute illnesses, as well as chronic conditions, such as:
  - high blood pressure
  - diabetes, dyslipidemia
  - thyroid dysfunction
  - metabolic disorders
  - respiratory conditions
  - renal dysfunction
  - ➤ back pain etc.
- Medical screenings and wellness medical check-ups: tests decided according to age, sex and family history.
- Mental health support: for patients and their families.
- Support for Occupational Medicine.

### **Cardiology**:

- **General cardiological consultations:** including of non-invasive procedures such as: 24 hours BP monitoring, 24 hours Holter monitoring, Treadmill (Stress Test), cardiac 2D echo etc.
- **Cardiological preventive check-ups:** evaluation of the short and lifelong cardiovascular risk score, laboratory and other investigations as recommended by Cardiologist Specialist from case to case, considering the age, gender, previous personal and family medical history and consultation's findings.
- Services on identifying cardiovascular risk factors or cardiological known conditions: hypertension, dyslipidemia, cardiac valvular disease, congenital heart diseases, rheumatic heart disease, fainting (syncope), fluctuating blood pressures etc.
- Heart problems associated with other medical diseases: diabetes, rheumatism, kidney or lung diseases etc.
- Support for the occupational health related cases.

### **Obstetric Gynecology (OBG)**:

- **Obstetrics and Gynaecology Consultations:** Offering guidance on puberty, diagnosis and treatment of sexually transmitted infections, and management of conditions like Polycystic Ovary Syndrome (PCOS).
- **Cancer Screening and Education:** Providing early detection services for breast and cervical cancer, including consultations, education on self-examinations, Pap smears, and breast ultrasounds.
- **Gynaecological Services:** Addressing concerns such as irregular menstruation, infertility, and pregnancy-related issues with appropriate consultation and counselling.
- **Pregnancy Care:** Monitoring pregnancy progress and creating personalized health plans for delivery.
- **Postpartum Support:** Conducting post-delivery assessments, offering advice on breastfeeding, and assisting with mother and baby adjustment.
- Women's Wellness Programs: Integrating wellness initiatives into preventive healthcare strategies.
- Occupational Health Support: Assisting with workplace health concerns, including postpartum return to work and managing breastfeeding while employed.

### **Radiology**:

- **X-ray services** for head, thoracic, spine, abdomen, hips, upper and lower extremities.
- **Ultrasound services** such as whole abdomen, upper abdomen, KUB/KUB-prostate, pelvic Non-OB, OBG pelvis USG and transvaginal USG, thyroid, carotid & breast, soft tissues, cardiology etc.
- Support for proper diagnostic and treatment monitoring process for all specialties.

### **Laboratory:**

- Laboratory services such as: hematology, biochemistry, immunology, hormones, occupational toxicology related tests etc.
- Support for proper diagnostic and treatment monitoring process for all specialties.




